TERMS AND CONDITIONS FOR COMMERCIAL EXHIBITORS

- 1) If for any reason it is necessary to cancel this Agreement, the Beamsville Western Rodeo must be notified no later than June 20th 2009. **There will be a 30% cancellation fee deducted from your refund for administrative costs.**
- 2) One standard 15 amp. 110 volt outlet will be available for your use. Any additional outlet/220 volt will cost \$30.00.
- 3) Two passes will be sent to you for admission into the grounds.
- 4) **The following item will NOT be allowed to be sold: Knives of any type, laser pointers/lights, exploding bags, cap guns. Drug related items, illegal items or any item that may be a safety concern. The Beamsville Western Rodeo/Lincoln Agricultural Society has the right to ask for items to be removed from vendor space.**
- 5) Vendors will be required to make use of all recycling bins provided by the Beamsville Western Rodeo.
- 6) Vendors wishing to sell draw tickets from their display must obtain prior approval from the Beamsville Western Rodeo committee.
- 7) Set up will be Saturday July 18th 2009 from 9 a.m. to 4 p.m.
- 8) Clean up for all vendors will be Sunday 19th 2009 at 6 p.m.
- 9) Gates will be open to the public at 5 p.m. July 18th and open at 12 noon on July 19th.
